 - Timeline for Fields Being Playable July of 2025

 - Wright Law Firm Kris did not feel that she could adequately represent us with her knowledge base.
 - Kostner, Koslo, Brovold not option since Village is represented by them
 - Johns, Flaherty & Collins have not heard back
 - Hale Skemp doable, estimated somewhere around \$1,000 or more, they think it will need to be a new lease; many questions. Motion to approve the use of Hake Skemp attorney up to \$2,000 at this time by Dan, second by Quentin. Motion carried and approved.
 - Addressing questions on the basis on who is responsible for year round upkeep of the buildings as the town would like to

have them open year round. Could look at having priority of building during a certain time period. Need to finalize the information of the lease as the use is detailed out as to what the organization would be on the line for.

- Discussion on Trempealeau Parkland Donation and Loan from August 8th Virtual Special Board Meeting:
 - Discussion was had that TYSC would not be able to take on a loan for \$337,000+ for synthetic turf at this time. \$50,000 donation is pledged though.

 - Middle School Dance affecting sign up of Gr 5th-8th? Since there is a dance class for that it most likely affected the numbers for the upper group.
